

2021 CBF WALK THE WATERSHED SHIRT CONTEST OFFICIAL RULES

General Contest Information:

- The sponsor of the contest is the Chesapeake Bay Foundation (CBF), 6 Herndon Avenue, Annapolis, MD 21403. Phone number: 410-268-8816.
- This contest is intended to reward Walk the Watershed participants. Contestants must raise \$150, or more, through their Walk the Watershed personal fundraising page.
- To be eligible, the individual participant must raise \$150 or more by May 15th on their personal Walk the Watershed page.

Who May Enter:

- This is open to anyone registered in the Walk the Watershed Challenge.
- You must be at least 18 years old to participate. If you have not reached the age of majority in your jurisdiction of residence at the time of entrance, then your parent or legal guardian must enter on your behalf.
- You must currently reside in one of the 50 states of the United States of America, or the District of Columbia.

How to Enter:

- Submissions will be accepted beginning on April 1, 2021, at 8:00 am Eastern Time and ending on May 15, 2021 at 11:59 pm Eastern Time.
- To be eligible for the giveaway, you must raise \$150, or more, on your personal Walk the Watershed fundraising page.
- To redeem your giveaway, you must complete the Walk the Watershed registration with the required information, including your size, style, name and address.
- You also need to acknowledge that you have read, understand, and agree to be bound by these Official Rules. By submitting an entry, you warrant that your entry complies with all the requirements set out in these Official Rules.
- All responses must be in digital format and submitted through the official Walk the Watershed registration.
- Only online entries will be accepted.
- Each Walk the Watershed participant is allowed one entry.
- Responses that contain obscene, defamatory, sexually explicit, or otherwise objectionable or inappropriate content will be disqualified in CBF's sole discretion.
